(which expression shall unless repugnant to the context or meaning thereof include his successors, legal representative and permitted assigns) appointing himself as Founder Trustee.

WHEREAS the Author is desirous of creating an Education and Public Charitable Trust with intend to achieve the Objects of Trust mentioned hereunder for alleviating human suffering eradication of illiteracy and poverty and the imparting sound education with opportunities for research

AND WHEREAS Author has set apart in favour of the trust a sum of Rs. 1000000=00 (Rupees Ten Lakh only) to form a corpus fund for the said Trust.

AND WHEREAS Author appoints other trustees of the trust to deal the subject matter of the trust and to promote the object of trust under Rules and Bye-Laws of The Trust set forth hereunder.

Now therefore, this deed of declaration of trust witness as under:

1.0.0. SUBJECT MATTER OF TRUST:

The Author doth hereby transfer a sum of Rs.10,00,000.00 (Rupees Ten Lakh only) in favour of the "**VIMLA VIKRAM CHARITABLE TRUST**" and unto the trustees. The founder trustee hold the said fund and will hold other properties that may be endowed or conferred from time to time to the Trust (hereinafter referred to as "**Subject matter of the trust**") for the purpose of the trust and shall deal the same under Rules and Bye-Laws written hereunder for the use and benefit of the trust (hereinafter referred to as "**Rules and Bye-Laws**"). The trustees shall out of the income realize from the properties, endowed and such other endowments or donations that they may get. Pay all taxes and rates and all expenditure connected with the trust.





- 2.4.2 To open, run, continue educational and vocational School College or Institution in healthy and salubrious surrounding to provide Primary to Higher Education in all subject of Science and Art side under the Educational Policy of State and Central Government including Agriculture Science, Teaching Education and Research Work.
- 2.4.3 To open, run, continue and maintain professional Institutional to provide education of Law, Commerce, Business Administration, Computer Application, Information Technology, Mass Communication, Pharmacy, Nursing/ Pathology and other job oriented courses.
- 2.4.4 To open, run and continue Medical College and hospital to provide Medical Education in Allopathic/ Aayurvedic/ Homeopathic/ Unani Medicine and Surgery including Dental and other advance surgery.
- 2.4.5 To open, run and continue I.T.I. Polytechnic, Engineering School/College to provide technical education of Civil, Architectural, Electric, Electronic, Mechanical, Aeronautical, Chemical, Computer engineering courses including Pharmacy and other job oriented courses.




3.3.0 AREA OF OPERATION: **ALL INDIA**

3.4.0 OBJECTS OF THE TRUST: **as herein above mentioned.**

3.5.0 DEFINITIONS: In this By-Laws where the context so requires the masculine shall include the feminine and vis-à-vis and the singular shall include the plural and vis-à-vis and the following words and expression shall have the same meaning shown against them unless the context require otherwise.

1. The "TRUST" shall mean **VIMLA VIKRAM CHARITABLE TRUST**.

5. The term "SUBJECT MATTER OF THE TRUST" means the Property of **VIMLA VIKRAM CHARITABLE TRUST**.
6. The "BOARD OF TRUSTEE" shall mean the Board of trustees of the **VIMLA VIKRAM CHARITABLE TRUST**.
7. The "EXECUTIVE COMMITTEE" shall mean the Executive Committee of **VIMLA VIKRAM CHARITABLE TRUST**.
8. The "CHAIRMAN/MANAGING TRUSTEE" shall mean Chairman /Managing Trustee of Management of the **VIMLA VIKRAM CHARITABLE TRUST**.
9. The "VICE-CHAIRMAN/MANAGING TRUSTEE" shall mean the Vice-Chairman of Executive Committee of the **VIMLA VIKRAM CHARITABLE TRUST**.
10. The "Executive Trustee" shall mean member of executive committee of the **VIMLA VIKRAM CHARITABLE TRUST**.

3.6.0 **BOARD OF TRUSTEES:**3.6.1 **Composition:**

The board of trustees will ordinarily consist of not less than Two and not more than eleven members. Initial Board of Trustees is hereby declared by the Author including himself as founder trustee along with following trustee as under:

(1)	Salil Singh Son of Sri Vikram Singh. (Author and Founder Trustee of the trust)	CHAIRMAN/MANAGING TRUSTEE
(2)	Anuradha Singh, Wife of Sri Salil Singh,	VICE MANAGING TRUSTEE
(3)	Suryansh Singh Suryavanshi, Son of Sri Salil Singh	EXECUTIVE TRUSTEE
(4)	Siddhant Singh Suryavanshi, Son of Sri Salil Singh All the above are Resident of Post Kodari Dih, Soorat Singh, Tulsipur District- Balrampur (U.P.) 271208. (Founder Trustee of the trust)	EXECUTIVE TRUSTEE

Other trustees may be co-opted by the CMT along with MT, if necessary, to make the total number to eleven. If and whenever the number of trustees is reduced to below three the continuing trustees shall appoint new trustees so as to make the total number of trustees for the time being to three. Trustee No.1 and 2 above will hold trusteeship for life thereafter their legal heir will hold the post of life trustee in the same capacity and trustees No. 3 to 11 above shall hold the office only for five years.

3.6.2 The trustees so co-opted shall hold office only for five years and are liable for retirement. The trustees whose term of office expires after a period of five year are eligible to be co-opted as trustees again by the existing trustees. The trustees may, if he so desires, resign his trusteeship even before the expiry of the term of his trusteeship. 3.6.3 Initial board of trustee shall be the supreme power of the Trust. The trustees shall appoint one among them as chief executive trustee of the board of trustee to look after day to day work of the trust.

3.7.0 **Salil Singh** the trustee above shall be the Chairman / managing Trustee or "CMT" for life and thereafter Trustee No-2 hold the CMT post thereafter his legal heir will inherit the post of CMT or CMT may nominate his successor either in writing or by will with necessary terms and conditions relating to tenure and powers and functions of such successor. **Only Salil Singh's** genealogy will hold CMT/MT post.

3.8.0 TRUSTEESHIP:

3.8.1 **LifeTrustee** - Except the legal heir of author and founder trustee, there is no provision of life trustee.

3.8.2 **Ordinary Trustee** - A Donor who will donate Cash or kind or immoveable assets of valuable price will have full devotion with the Object of Trust such Donor may be ordinary Trustee of the Board of Trust.

3.9.0 Eligibility:

A person may be Trustee of the Trust,

- i- who will be a resident of India,
- ii- who will be a major and attained the age of 18 years,
- iii- who will be of sound mind competent to contract,
- iv- who will be devoted with object and By-Laws of the Trust.

3.10.0 Disqualification:

In following circumstances a Trustee shall be ceased from the Trusteeship of the Trust and will be relieved from the liabilities of Trust,

- i- On death.
- ii- On resignation
- iii- By termination- on the charges of concealment of material facts, acts against the object, violation of any rules and regulations of the Trust, becoming insolvent, lunatic and adjudicated for economical offence, criminal acts or offences, the Trusteeship of such Trustee shall be terminated by CMT/MT without any prior notice.
- iv- Due to absent from the meeting.


3.11.0 Meeting:


Generally the meeting of Board of Trustee will be held once in a year but it may be called any time. provided, however it may be called in case of emergency. Every meeting shall be presided over by the CMT.

3.11.0 Notice:

- i- All notices shall be served upon the Trustees of the Board either personally or through post to such Trustee at the address mentioned in the roll of Trustees.
- ii- Any notice served by post shall be deemed to have been served on the day following three days of the date on which the letter / notice served.
- iii- All the Trustee of Board will be informed before 15 days from the fixed date of meeting for Board of Trustees in writing mentioning the agenda of meeting. In case of an emergency the Trustees will be called before 24 hours of fixed date and time of emergency meeting.
- iv- Date of Annual General Meeting - It is must to hold annual general meeting of the Trust once in a year in the month of June after completion of statutory audit of the Trust.




For each meeting of Board the presence of 2/3 Trustee will be treated complete Quorum.


3.13.0 POWER AND FUNCTIONS OF THE BOARD OF TRUSTEE:

3.13.1 The power and function of the board shall be as follow;

- i- To serve as policy making and supervisory body for the Trust and executive committee of the trust and its institutions.
- ii- To enlist the continued cooperation and support of voluntary agencies, welfare organization, worker, union, industrial establishment, development agencies, zilla saksharata samiti, state and central Government department etc for the programme.
- iii- To establish such centers and sub centers as are necessary to organize and implement the programme.
- iv- To set up such committees as are found necessary to manage the day to day affairs of the thrust to implement its object.
- v- To periodically review and from time to time assess, the programmes implemented by and through the Executive Committee of the Trust with a view to effect modifications and improvement.
- vi- To assess the financial requirement of the Trust in keeping with its objectives and approve the budgetary estimates.
- vii- To exercise overall supervision and to ensure that the money spent achieves the objectives and that the targets are reached.
- viii- To appoint all categories of staff for conducting the affairs of the Trust to fix the amount of their remunerations, to define their duties and to grant allowances and other emoluments.
- ix- Generally, to take all such measures as may be found necessary, from time to time to promote the objectives for which the Trust has been set up.
- x- The Board of Trustee shall have power to make additions or alter or amend or rectify the provision of this Trust by a resolution supported by two third majority of total number of Trust, if in its opinion it is necessary in the interest of its object.
- xi- The Board of Trustee shall have the power to form an Executive Committee to conduct and manage the affair of Trust to promote its objects.
- xii- The Board of Trustee shall have the power to appoint such other sub-committees and panels of experts to deal with specific problem or groups of problems for such purposed and with such powers as the Board of Trustee may think proper.
- xiii- In case of any dispute of Executive Committee or any sub- committee, the Board of trustee shall have absolute power to dissolve the such committees without any delay and shall form new committee, if require.

3.14.0 EXECUTIVE COMMITTEE: Composition, Meeting, Notice, Quorum, Right and Duty.

3.14.1 Composition: Executive Committee will be formed by the Board of Trustee after the registration of this trust among its Trustee and donors. The Executive Committee will have four members who will be designated as under;

- i- Chairman /Managing Trustee,
- ii- Vice-Chairperson /Managing Trustee
- iv- Two Executive Trustee.

3.14.2 Tenure:

The tenure of the Executive Committees shall be for five years and it shall automatically be over at the end of the five year term.

3.14.3 Meeting:

- i- Every meeting shall be presided over by the Chairman /Managing Trustee, and in the absence of the Chairman/ Managing Trustee, the Vice-Chairman shall preside over the meeting.
- ii- The executive committee shall meet at least twice in a financial year and not more than six months shall elapse between any two consecutive meetings of the executive committee. These meeting shall be convened by the Chairman Managing Trustee.

3.14.4 Notice:

- i- The notice in writing of each ordinary meeting shall be delivered or sent to each Member at his usual address along with agenda of meeting.
- ii- The notice shall indicate the date, time and place of the meetings. The notice of the meeting shall be served on Member either personally or by post not less than 15 day in advance.
- iii- An emergency meeting of the Executive Committee shall be called in extra ordinary circumstances on such occasions, at least one days notice.

3.14.5 Quorum:


Two Third Members of the executive committee present in person shall constitute a quorum at any of its meeting. No meeting shall take place in the absence of the quorum provided, once suspended meeting there is no need of quorum on the same agenda for next meeting.

3.14.6 Power and Function of the Executive Committee:

The power and function of Executive committee shall be as follows;

- i- The appointed Executive Committee is fully empowered to manage the affairs of the Trust. It shall also have the authority to exercise such powers of the Board of Trustee as may be delegated to it from time to time.




- ii- The appointed Executive Committee shall have the power with the sanction of the Board of Trustee to make such bye laws as they think proper for the preparation and sanction of budget estimate, the sanction of expenditure, entering into contract, making investments and for any other purpose as may be necessary.
- iii- The appointed Executive Committee may, by resolution, appoint such sub committees for such purpose and with such power as the executive committee may think fit. Such sub-committee may consist of persons who are the Trustees of the Board of Trust but who, by reason of their experience and qualification etc. may be considered useful for promoting the aims and objectives of the Trust.
- iv- The appointed Executive Committee may, by reason, delegate to a sub-committee or to authorize such of its power for the conduct of its business as it may deem fit, subject to the condition that the action taken by any sub-committee or the person under the powers delegated to them by this sub-committee shall be reported for confirmation at the next meeting of the executive committee.
- v- To regulate the expenditure and to manage the account of Trust.
- vi- The appointed Executive Committee shall meet as often as may be necessary or convenient to transact business. The Executive Committee might transact business and take decisions also by circulation of papers.
- vii- Without prejudice to the generality of the provisions contained above Executive Committee may also empower the CMT and or General Secretary to represent or act for the Trust in any matter concerning the properties, funds, investments, borrowings and making or cancellation of any instruments for any of these purposes.
- viii- The Executive Committee will have full and confirmed power to regulate and manage the affair of Trust and any of its institutions established by the Trust as it may establish in pursuant to these present.
- ix- The appointed Executive Committee may set up one or more sub-committee for the routine and day to day management and administration of such institutions under their ultimate supervision and control and may cancel any time any type of sub-committee of any particular activity with the consent of CMT/MT.

Right and Duty of Member of Executive Committee:

3.14.7 Chairman /Managing Trustee (CMT):

CMT is empowered to exercise all the power and function of executive committee as over all in-charge of the trust including the following function and he is empowered to delegate his power to other members of executive committee to facilitate the day to day affairs of the trust.

- i- To appoint and nominate Executive and General body committee for Running any one or more School/college/institutions as per required by Boards or university to manage the School/college/institutions and CMT /MT will hold the post of Manager/ Secretary of the running School/college/Institutions and they engage Teachers, Professors, Instructor, Experts of good moral character and conductible to impart efficiently and economically up to date instruction to pupils and students in modern sciences, industrial avocations, research work, intellectual and other useful pursuits.
- ii- To purchase, take on or otherwise acquire any land, building or other property. moveable, immoveable in the name of Trust, which may be necessary for carrying on the function of the Trust.
- iii- To invest fund or money of the Trust in such a manner as may, from time to time, be determined by it.
- iv- To draw, accept, make endorse, discount and deposit Government of cheques and other promissory notes, bills of exchange, or other negotiable instruments.
- v- To sell, exchange, lease or otherwise dispose off all or any portion of the properties of the Trust moveable or immovable on such terms as it may think and proper without prejudice to the interest and activities of the Trust.
- vi- To raise and borrow money on bonds, mortgage, promissory note or other obligation or securities, founded or based upon all or any of the properties and assets of the Trust with or without any securities and upon such terms and conditions as it may think fit and to repay and redeem any money borrowed.
- vii- To accept donation, grants, presents and other offering and to deal with the same for the purpose of the Trust.
- viii- To receive money from Individual, Firms Societies, Banks, Financial Institutions, Corporate Body on interest or otherwise with or without securities to carry on the objects of the Trust.
- ix- To invest, dispose of, transfer and otherwise deal with the subject matter of the Trust in such manner as he deem fit so as to enable carry on the objects of the Trust effectively.
- x- To execute, signed all deed and document relating to transfer, mortgage and lease of the trust property and present before competent registering authority or appoint other official trustee in this behalf.
- xi- To sign and verify Plaintiff, written statement, application, revision and affidavit and submit the same before any court of law or authority or appoint any trustee or advocate, parokar in this behalf to deal the court matters.
- xii- The CMT shall have power to administer the fund of the Trust and any power exercisable by the Executive Committee of Trust may be delegated to the CMT.

- xiii- The other office bearers of the Trust shall be appointed by the CMT.
- xiv- The CMT of the Trust will be entitled to receive T.A., D.A. and other essential expenses for the Trust work, attending meetings and making tour programme either in India or overseas.
- xv- Without prejudice to the power of the Board of Trustee of Trust the CMT shall manage and administer the affairs of the Trust and shall also exercise such power and function as may be delegated to him by the Board of Trustee of Trust.
- xvi- The CMT may authorize any of Official Trustee of the Trust to act on his behalf to operate bank accounts, etc.
- xvii- The CMT shall have the power to convene ordinary and extra ordinary meetings.
- xviii- The CMT shall have powers to invite to any other to attend to the Board of Trustee Meetings as a special invitee.
- xix- The CMT shall have right to casting vote in case of division.
- xx- The CMT shall issue the appointment order for the General body & EC.
- xxi- The CMT shall place the matter regarding disciplinary action against the other Official Trustees in the Board of Trustee of Trust.
- xxvi- The CMT shall convey the decision of the Board of Trustee and Executive Committee to concerned authorities.
- xxvii- The CMT is empower to appoint the trustees any of subject specialist for Executive Committee created by the Board hereinabove to manage the function of the Trust and they will remain under the control of CMT to perform their duties,

a) Vice-Chairman/Chairperson:

In the absence of CMT, the Vice-Chairman/Chairperson shall preside over the meeting of the Executive Committee and look after the legal affair of the trust in supervision and control of the CMT.

3.14.8 ACCOUNTS AND AUDIT:




3.15.0 SPECIAL PROVISIONS:

2.22.1 The Trust will follow the instructions of U.P. Government Order No. 2762/ 15-13/91-4/45/91 dated 30-11-1999 and also abide the instruction in case of recognition/ affiliation from C.B.S.E.

- i- That the registration of Trust, the affiliation be got renewed from time to time.

- ii- That a Trustee from the Trusteeate of Education will be included in the Executive Committee of the Institutions.
- iii- That 10% admission will be reserved for the Schedule Cast (SC) / Schedule Tribe (ST) and Other Backward Class (OBC) for the talented students and fee will be charged from them as per the directions and orders issued by Madhyamik Shiksha Parisad / Basic Shiksha Parisad.
- iv- That Institution will never demand any aid from U.P. Government and if institution is already recognized with U.P.S.E.B. said this recognition will be cancelled as institution is affiliated / recognized with C.B.S.E. New Delhi. That institution will pay the salary to their staff as per the norms fixed by the concemed departments.
- v- That the institution will keep the records of the service conditions and appointment of the staff and also sanction pensioners benefits to them as applicable under the rules.
- vi- That Institution will follow the instructions of the U.P. Government.
- vii- That the records will maintained strictly as per the orders of concerned authorities.
- viii- That no amendments will be allowed in the above terms and conditions without the prior permission of the concerned department.

3.16.0 MISCELLENEOUS PROVISIONS:

3.16.1 All acts and proceeding of the Trust shall be taken and conducted in the name of the Trust through its CMT.

3.16.2 The fund of the Trust shall consist of the following:

- i- Grants made by or through the Government of India or the State Government including Grants, donations from other sources.
- ii- Any income other than the grant-in-aid from Government of India.
- iii- Income from Investments. Fee collected from the trainees and contributions fee etc.

3.17.2 ADVISORY BODY:

The Executive Committee may maintain a set of advisors for the purpose of utilizing their services in furtherance of the object of the Trust.

3.18.0 RECORDS OF TRUST AND EXECUTIVE COMMITTEE:


